For over 70 years, Jewish Family & Children's Service of Southern New Jersey (JFCS) has been providing compassionate practitioners, caring volunteers, tireless advocates, and comprehensive social services for those in need. With our widening circle of volunteers, donors, community partners, board members, and staff, we will create endless possibilities, and a ripple effect of positive change for years to come. 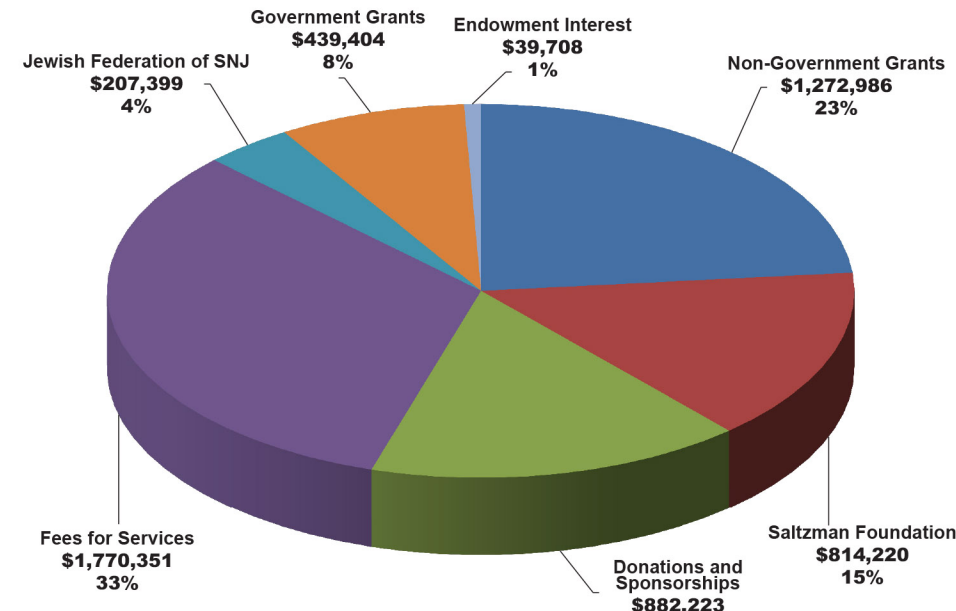

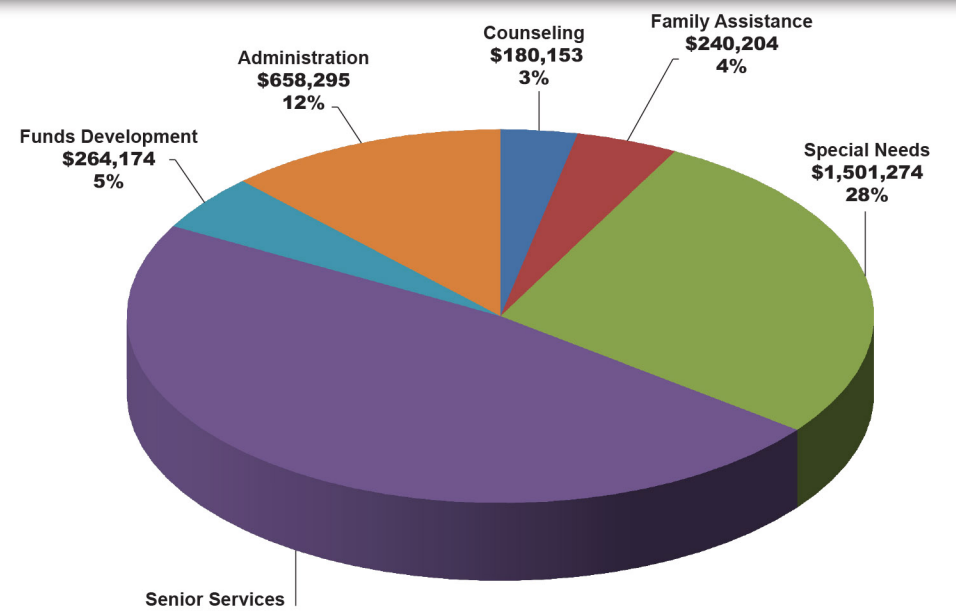
